BCN Board Meeting Minutes – February 9, 2012

I. Welcome

Jim King called the meeting to order at 6:40 PM.

II. Introductions

The attendees introduced themselves. A quorum was present.

III. Approval of January Minutes

Minutes for the January meeting were approved.

IV. Admit New Member Neighborhoods

Twenty-eight neighborhoods paid 2011 dues. As of this February meeting, seventeen neighborhoods had paid 2012 dues. No new neighborhoods asked to be admitted.

Habersham Park had been shown on BCN's map in place of the Arden/Habersham, Argonne Forest and Wyngate neighborhoods; it was concluded it was appropriate to show the original three neighborhoods instead.

V. Neighborhood Governance Issue (D & O Insurance)

Gordon Certain talked about North Buckhead's coverage: both D & O and liability. **Walda Lavroff** said the reason North Buckhead got D & O insurance was zoning, that other neighborhoods they had worked with had been sued and, that North Buckhead felt it needed to protect itself. They understood that their individual homeowners' policies would protect them individually, but that also caused problems. Asked why the liability coverage? Gordon said it was because of their involvement in park design, operating traffic radar and general paranoia. Security patrols by off-duty police officers was identified as a reason to consider liability coverage. Several attendees wondered if BCN could help neighborhoods get better insurance rates.

Kathy Collura will send a ServerMonkey survey asking questions about neighborhood's membership policies and insurance coverage to be discussed next month.

VI. Guest Presentation - Bobby Jones Golf Course and Park Conservancy

Roxanne Smith briefed the BCN about the creation of the Bobby Jones Conservancy. About a year ago, the Conservancy was formed upon the realization that the Bobby Jones Golf Course clubhouse and golf course needed restoration and that the creek that runs through it did too. They also discovered that the Atlanta Memorial Park is actually a regional park which includes the tennis center and the golf course. The founders of the Conservancy were the leaders of the six contiguous neighborhoods: Collier Hills North, Collier Hills, Memorial Park, Channing Valley, Springlake and Peachtree Battle Alliance. They wanted to ensure that all residents were represented and respected in the process of redeveloping the golf course and the surrounding areas and connecting paths. The conservancy is a 501(c)(3) and is beginning to raise funds through a matching grant. They are planning a feasibility study and preliminary master plan for the entire park area. They plan to launch a web site and membership drive in about two months as they set out on this approximately ten year project.

Marty Elgison spoke next. He has represented the Jones family for about 25 years. He said the golf course is 80 years old and that renovating the golf course would be a fitting honor to Bobby Jones' memory.

Bob Hughes with HGOR spoke showed pictures which illustrate the goals of the master planning process: creek restoration, revitalization of Memorial Park, enhancement of neighborhood connectivity, renovation of the golf course, renovation of the beautiful old club house, and to work with Bitsy Grant Tennis Center to optimize space utilization. They are expanding the park by including parcels recently

purchased with FEMA money. They plan to narrow Woodward Way and widen the nearby creek bank and tree cover. They plan a tree inventory to guide the restoration plan. Invasive species will be removed. They plan to connect existing paths in the area to improve pedestrian connectivity to the walking loop they plan around the golf course. They are considering the development of pervious parking areas to help the club house area be more useful when it is renovated.

Bob Cupp spoke about the stewardship and sustainability related to the golf course. The golf course should be economically viable, but it's not. Physically the golf course is "tired". The course should be sustainable. The course should be playable more days. So a redesigned course should be less prone to closure due to flooding. Removing a bridge is a way to do this. He showed various configurations of the golf course, some with 18 holes, some with 9 supporting practice areas.

Garth Peters, commenting about the structure of the conservancy, said his Memorial Park neighborhood is really pleased that the overall redevelopment project "is something that has been approached by neighborhoods, for neighborhoods, with the consciousness of the neighborhoods. [It] is a much different approach than some of the other conservancies have." Jim King noted that other regional parks have had problems because affected neighborhoods have not "been at the table".

Jane Rawlings asked if the Bobby Jones Conservancy would be interested in connecting to the low impact pedestrian trails that the South Fork Conservancy is setting up. The response was "yes", although immediate efforts will focus on neighborhood needs.

VII. Committee and Liaison Updates

- Communications Committee Bob Schneider reported some changes had been made to the test web site at www.buckheadcouncil.yolasite.com. He intends to make a five minute presentation of the site at the next BCN board meeting. He requested that Gordon Certain and Elizabeth Pritchard meet with him prior to that meeting to discuss additional changes. Bob's email is bschneider@gardenhills.net.
- Education Leslie Churchill said nobody is happy with the new redistricting proposals. Overcrowding (present or future) at Inman is tending to push some of their student population into our cluster. New APS proposals are planned for March.
- Executive Committee No report.
- Membership No Report.
- Neighborhood Governance/Topics Best Practices: No report.
- Parks Gordon Certain reported that Director of Parks Doug Voss is attending the weekly meeting of COPS (Community Oriented Policing Services). Doug wants parks related problems which need attention on to be reported to him by email each week before 9 AM Tuesdays: dvoss@atlantaga.gov or 404-546-6742.

Gordon also reported that surveying of the GA 400 Trail is underway and that the North Buckhead Quarry which was planned to be a park has been sold to a third party and is no longer available.

- **Property Taxes George Mirgorod** reported that the property tax moratorium had expired.
- **Public Safety Tad Linder** reported that Zone 2 had a 13% decrease in crime. Zone 2 has been expanded in territory and staffing. Tad would like to coordinate emails among neighborhoods.

Hannah Chung has resigned from her job as community prosecutor; no replacement has been announced. **Garth Peters** said the Buckhead Coalition is following up with the landlord at Hannah's old office to make sure the office space remains available.

Garth also mentioned a new system called Smart911. It permits families to let the police know in advance of medical issues, numbers of people in the household, etc. so that if a 911 call is placed, the responding personnel are forewarned and prepared.

Kathy Collura commented that non-emergency calls had been placed on four occasions to the COPS unit's telephone number and a voicemail system answered each time, offering a call back.

- **Redistricting Jim King** reported that the City Council and state redistricting plans had been finalized. Fulton County is still being developed.
- Transportation, Development and Infrastructure Ron Grunwald spoke about the light rail project connecting Cumberland mall to the Arts Center station. He wrote an email requesting that Atlanta neighborhoods be contacted so they could be involved, which hasn't happened yet. Four alternate light rail routes are under consideration.

Jane Rawlings mentioned that MARTA was making routing decisions in March for the Lindbergh to Clifton Road (Emory) line.


