I. Welcome

Jim King called the meeting to order at 6:40 PM.

II. Introductions

The attendees introduced themselves. A quorum was present.

III. Approval of February Minutes

Minutes for the February meeting were approved.

IV. Admit New Member Neighborhoods

Twenty-eight neighborhoods paid 2011 dues. As of this February meeting, twenty-five neighborhoods had paid 2012 dues. No new neighborhoods asked to be admitted.

Garth Peters said a new Argonne Forest Civic Association, represented by Elden Potts, was being organized and may have interest in joining BCN after they elect officers in late March.

V. Neighborhood Governance Issue

Membership, Web Site and Insurance

Kathy Collura provided two handouts related to a survey she had conducted. Twenty-four neighborhoods completed the survey. The <u>first handout</u> showed results for various questions related to membership practices, web site operation and insurance.

Most neighborhoods reported membership eligibility for townhouses, condos and apartments. Most neighborhoods also allowed membership by tenants. Associations with membership of only single-family homes tended to have a higher percentage of membership. Membership levels have been generally stable over the past five years for neighborhoods participating in the survey. A variety of methods were used by neighborhoods to solicit annual memberships; the most common effective method was by letter.

Twenty-one of the twenty-four neighborhoods had web sites. Eighteen were operated by unpaid volunteers.

The second <u>handout</u> listed insurance companies and agents and the costs of the coverage they provide responding neighborhoods. Eleven of the neighborhoods carry D&O insurance while nine carry liability.

More detailed information about the survey was made available earlier on the BCN web site.

Alliance Theater

Bob Schneider discussed his experience with the Alliance Theater, working with **Gary Sayers**, Marketing Director at Alliance Theater, to set up a *Garden Hills Night* at the theater. They got a package with a meal before, parking and discounted seats. A 15% discount on tickets is available for 10 or more neighbors and 25% for 20 or more. Nextdoor Neighborhood Web Sites

Jim King mentioned that his neighborhood had worked with a web company called <u>Nextdoor</u>. The Chastain Park neighborhood launched their Nextdoor site in February and already have 350+ households involved. The system lets neighbors contact each other. They can exchange recommendations about painters and plumbers, report lost and found pets, and so forth. Boundaries for all Buckhead neighborhoods have been preloaded in the system. City officials (police, public works, etc.) can make postings into a Nextdoor neighborhood site without being able to see the internal neighborhood postings

and can get responses from the neighborhood participants. Jim sent a <u>flyer</u> sent to BCN neighborhoods with more information on how Nextdoor works.

VI. Guest Speaker - Representative Phil Gingrey, District 11

Phil Gingrey, a Georgia native, is in his fifth term as a Congressman. Gingrey is a medical doctor who also attended Georgia Tech. Beginning with the 2012 election, his 11th district will include Cherokee County and 45,000 people in northern parts of Buckhead and Gingrey will be a candidate for reelection – 45% of the new district will be new to the 11th. The new 11th district is shown on this Metro Atlanta Congressional map.

Gingrey said he appreciated meeting with BCN and offered to attend meetings of individual Buckhead neighborhood associations in the future to get to know the people. He introduced his staff, Janet Byington and Andrew Johnson.

He said relatively little was going on in Washington because of the election. He commented that the moratorium on member initiatives ("earmarks"), prompted by things like "The Bridge to Nowhere", would probably go away some day but the system needs to be reformed. He said the Port of Savannah is in tremendous need of federal funding, perhaps \$300 million.

Gingrey serves on the important House Energy and Commerce Committee, one of Congress' oldest committees, and also on the Committee on House Administration. Gingrey hasn't taken a position on the ten-county TSPLOST issue – he said he can't guess how the vote will come out. He senses that there is opposition in Cobb regarding their transit expenditures which will actually involve a lot of work performed in Atlanta and not so much work in Cobb. An attendee asked whether the projected technological changes, which will result in more people working at home and fewer commuting, had been factored into the TSPLOST plan – he hopes so.

Walda Lavroff asked if the scope of the Energy and Commerce Committee might be too big since it includes areas like the Internet. He said committees can be too big – he said they had held a number of hearings on cyber-security and it is "very frightening", to individuals, businesses and to our nation. A question was asked about the on-line businesses taking business away from brick and mortar businesses and not paying their fair share of taxes. Gingrey said that was highly controversial – brick and mortar businesses argue that on-line sales should be taxed; others say we are already taxed too much.

Gingrey said the federal expenditures are approaching 20% to 25% of GDP. Historically, it has been 18%. He hopes to bring it back down to 19.5%. He also advocates a balanced budget amendment. Glenn Delk suggested that balancing could be achieved without an amendment if the law required that Congress members not be paid until it is – Gingrey said similar legislation has been proposed.

VII. Committee and Liaison Updates

- Communications Committee Bob Schneider reported that the test web site at www.buckheadcouncil.yolasite.com, while not complete, was ready to be moved to production status. He will adapt the site to be able to show local news items in coordination with local blogs and newspapers. Bob's email is bschneider@gardenhills.net.
 - Debra expressed concern that portions of the meeting were being recorded on video. The BCN members will think about the issue.
- Education Leslie Churchill said new recommendations were out and would be voted on in a month. Buckhead will not have a new elementary school an attendance "bubble" is expected but after it peaks, the schools should be adequate. All school, with two exceptions, should be at or below capacity. Classrooms and perhaps a gym will be added to Brandon. Garden Hills will be over capacity for a short time portables were being considered and if that doesn't work, space will be sought for a kindergarten as was done with Smith. with an 800 capacity facility. When the new North Atlanta is in use, the middle school will be relocated to the current North Atlanta building and E Rivers will use the Sutton building for 18 to 24 months. The new E Rivers will be in use in 2015 and Sutton will be available as a middle school facility, perhaps as a sixth grade academy. APS will take feedback until March 25 and will post an updated proposal on March 30. The final recommendations will be posted on April 9 and BOE will vote on it on April 10. 13 schools are to be closed and some board members are unhappy. No attendance line changes are planned. **Jim King** said some neighbors are organizing to support two middle schools rather than the sixth grade academy.

- Parks Gordon Certain reported that Director of Park Design Paul Taylor has resigned and that George Dusenbury had been suspended without pay for five days over a personnel issue. North Buckhead Civic Association is doing a membership survey on the GA 400 Trail. That trail will connect near I-85 to the South Fork of Peachtree Creek Trail and the Beltline Trail.
- **Property Taxes George Mirgorod** reported that Burt Manning has resigned. He will be working as a trainer for the Department of Revenue.
- **Public Safety Lt. Marshall Roberson**, the evening watch commander for Zone 2, said the biggest problem on his watch is car break-ins. He stressed that we are their eyes and ears if we see something, say something *call 911 first* with the best description you can provide.
- **Redistricting Jim King** reported that Fulton County published maps but that they may not be approved.
- Transportation, Development and Infrastructure Jim King reported that two GA projects, the Northern Concourse pedestrian bridge and the I-85 ramps, had been started. The ribbon cutting ceremony was conducted on the US 41/Chattahoochee bridge project.


